

ORDINANCE NO. 5.)

AN ORDINANCE CREATING "CLASS B" LICENSES AND FEES

The Board of Supervisors for the Town of Pepin does ordain as follows:

1. The Town of Pepin shall issue no more than one (1) "Class B" license for retail on premises consumption of alcoholic liquor under Chapter 125;

2. Any "Class B" license holder may sell intoxicating liquor in the original package or container in multiples not to exceed four (4) liters at any one time and to be consumed off of the premises where sold pursuant to Sec. 125.51(3)(b). Wine and beer may be sold for consumption off of the premises in the original package or container by a retail "Class B" license holder in any quantity;

3. All operator's licenses under Sec. 125.17, Wis. Stats., shall be valid up to two (2) years and shall expire on June 30th;

4. The Town of Pepin shall not issue any license under Chapter 125, Wis. Stats., if any of the following circumstances exist:

a. If the licensee owes municipal taxes, assessments, or other fees, unpaid municipal forfeitures. Sec. 66.117. This section shall apply to all municipal licenses, but shall not apply to any taxes or other debts to units of government other than the Town of Pepin;

b. No license may be issued or renewed if the licensee has an indebtedness for fermented malt beverages outstanding for more than fifteen (15) days. Sec. 125.33(7)(b);

c. No license shall be renewed if the business is not in operation at the time of the license renewal and has not been in operation for at least five (5) months out of the preceding twelve (12) month period.

5. License fees:

a. The following fees shall be paid by license applicants for the issuance of the following licenses:

i. "Class B" License under Sec. 125.51:  
\$ 400<sup>00</sup>.

ii. Operator's License under Sec. 125.17(1-3):  
\$ 10<sup>00</sup>.

iii. Temporary Operator's License under Sec. 125.17(4): \$ 5<sup>00</sup>.

iv. Provisional Operator's License under Sec. 125.17(5): \$ 5<sup>00</sup>.

b. All license fees shall be paid prior to the issuance or renewal of a license.

c. There shall be no refund of license fees if the license is denied, cancelled, or surrendered. There shall be no proration of license fees for a part year except for the initial license year for "Class B" licenses. Sec. 125.51(9)(a), Wis. Stats.

d. Applicants for "Class B" licenses shall pay the cost of publication of the license application at the time the application is filed. Sec. 125.04(3)(g)(6).

6. This ordinance shall take effect after its passage and publication.
